

## BC Summer Swimming Association Notes to the Financial Statements

Year Ended March 31<sup>st</sup>, 2016

#### 1. General Information

The B.C. Summer Swimming Association (the "Association") is incorporated under the Society Act of British Columbia. The Association is a provincial organization operating and regulating summer aquatic sports in British Columbia. The primary objective of the Association is to promote the development of its athletes through participation in competitive aquatic sports and to provide opportunities for training, competition and related activities in communities throughout British Columbia and surrounding areas.

The Association does not consolidate the financial results of the participating regions as these entities are not considered to be subsidiaries of the Association and the Association does not have direct financial control over these regions.

The Association is a not-for-profit organization registered under the Income Tax Act and, as such, is exempt from income tax.

#### 2. Significant Accounting Policies

#### Basis of Presentation

These financial statements have been prepared by management in accordance with Accounting Standards for Not-for-Profit Organizations ("ASNPO"). These financial statements reflect the combined assets, liabilities, net assets, revenue and expenses of the Association's provincial office and its operations.

#### Revenue Recognition

The Association follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year when the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

#### **Donated Services & Supplies**

The Association benefits from the donated services of time from volunteers for the various activities conducted on its behalf and donated supplies from various sources. These donated services and supplies are not recognized in the financial statements.

#### Inventory

Supplies (rulebooks & officials pins etc.) purchased are capitalized as inventory using the weighted average cost method. As of March 31, 2016, \$1,076 (2015 – \$3,956) of these supplies have been capitalized on the balance sheet.



#### Use of Estimates

ASNPO requires the Association to make estimates and assumptions about future events that affect these financial statements. The Association believes that the estimates used are reasonable; however actual results could differ from those estimates. Significant areas requiring the use of estimates relate to the determination of the useful lives of assets for amortization, provisions for uncollectible accounts receivables, and the amounts recorded as accrued payroll liabilities.

#### Capital Assets

Capital assets are recorded at cost. They are depreciated on a straight-line or declining balance basis over their estimated useful life at the following rates:

Buildings 4% Declining Balance Fixtures and Equipment 12.5% Straight Line

Capital assets exceeding \$1,000 are capitalized. Deprecation is taken in the year of acquisition using the half year rule.

#### 5. Grants & Club Reimbursements

The Association granted funds and reimbursed certain expenses of member clubs and regions as approved by the Board of Directors. This data relates to any grants or reimbursements paid in the fiscal year.

#### **Capital Funding Grant Program**

Grants were paid to both clubs and regions for capital expenditures. Clubs and regions were required to apply for funds through an application and review process. Data below is broken out regionally, but some member club received grants directly.

#### Club Reimbursement - Hy-Tek Sports Software

The Association continued with reimbursing clubs and regions for the upgrade cost of the Hy-Tek Sports Software program as required. For the year ended March 31, 2016, the total reimbursement was \$12,996 (2015 - \$2,119).

#### **Club Reimbursement - Officials Name Tags**

The Association reimbursed clubs and regions through a direct rebate to cover the cost of name badges and pins. For the year ended March 31, 2016, the total cost absorbed by the Association was \$4,568 (2015 – \$1,879).

#### Financial Aid - Club Membership Fee Assistance

The Association provided financial assistance directly to clubs who applied on behalf of athlete families who were not able to afford the full amount of clubs fees for the 2015 summer swim season. Financial assistance was no more than 50% of the total fee charged by the member club. For the year ended March 31, 2016 the total assistance provided was \$3,065 (2015 - \$NIL)






## **Financial Overview**

## **President's Report**

Season number 58 is almost finished and we are just two very short years to our 60<sup>th</sup> Anniversary. 60 years is a lot of swimmers and parents. Imagine how big a homecoming that would be. When I think back to all the people I have met through the BCSSA over the years I am just a little bit overwhelmed, so many friendships and so many connections. You should start planning where you'll be in August of 2018 and maybe we can have a huge 60<sup>th</sup> Anniversary Homecoming for Summer Swimming in BC.

There were two major initiatives this past year. The first is our new rule book. Thank-you to Francis Cheung and his committee for all their work and a special thank-you to Brian Webster for the editing. The new rule book is readable online, on your tablet, on your phone and for some of us, in a book in our back pocket. The layout did have to be reformatted to be readable on tablet and phone so the number system is changed but going forward any changes to the rules will be immediately updated and everyone can access the rules easily. The rewrite was a lot of work. The last time there was a major rewrite of the rules was in the late 80's. I was involved with that rewrite. We thought we were doing very well because we were using the latest equipment, a MAC 512 and floppy discs (512 stood for 512 K). We would make suggested changes, save to the floppy and then mail the floppy to the rest of the committee who could then look at it and do a proofread. Eventually it was mailed to a printer who did up our books. This was all prior to that newfangled intranet.

The second major initiative was the BCSSA Strategic Plan, once again, a very big thank-you to our Vice-President, Francis Cheung. The Strategic Plan is available online and it has been distributed to the appropriate government agencies. The Plan has been very well received and gives the Association some guidance for the coming years. I would encourage you to take a few minutes and have a look at it.

My personal highlight this past year was the Coaches Conference held for the second time at RockRidge Canyon. We had an even larger turnout of coaches, especially young coaches. I think the strongest part of the conference was having senior BCSSA coaches as presenters. I don't think I have ever been in presentations that were so well organized and so relevant to the coaches in attendance. We do have to decide if we are going to do the coaches conference again next year and if we will return to Rock Ridge but regardless, having BCSSA senior coaches as presenters was a win. Thank-you to our Coaching Rep, Lindsay Van Genne and Disa for all their work to make the conference happen.

This year we are in the second year of the enhanced Ian Allen Scholarships and the second year of our Regional Bursary awards. The extra funding for the Ian Allen Scholarships will run out next year so if anyone is looking for a good cause to make a donation to, think about our scholarships and bursaries.

## **Vice-President's Report**

We completed several major projects this past season that will define the organization for years to come. I am pleased to report the following:

#### **New Rule Book**

The second phase of the Rule Book edit process was completed. The swimming discipline of the Rule Book was completely reworded and a separate Rule Book was created for each discipline. We have caught a couple of minor errors in the Rule Book so far and the corrections have been posted on the BCSSA website. We would be pleased to receive your feedback on the new Rule Book.

I would like to acknowledge Brian Webster for taking on the monumental task of rewriting the Rule Book. The rules are now reader-friendly and it doesn't take a lawyer to interpret the rules.

#### BCSSA Strategic Plan 2016 - 2020

The BCSSA Strategic Plan ("Plan") was endorsed by the BCSSA Board at their January 2016 meeting.

The role of the Plan is to guide all planning processes for the association as a whole based on three fundamental elements: our vision, our mission and our core values. Built on input from its membership, the Plan is a living document that will guide BCSSA over the next five years. It is a mechanism to proactively address opportunities and challenges as they arise in order to achieve our vision and mission and provide opportunities for training, competition and activities in communities throughout BC and surrounding areas. The Plan will continue to evolve as tactics are achieved and the needs of the association change.

The Plan will focus on four Priority areas that describe where we think we most need to move forward and achieve better results. Making progress in these Priority areas will define our success over the next five years and anchor our accountability to our competitors, members, clubs, regions, and the Board.

#### Priority 1: Organizational Development

Invest in our organization, people and processes, while ensuring financial sustainability.

#### Priority 2: Community Building

Develop and grow a culture of citizenship, strong ethics, commitment, dedication, and volunteerism.

#### Priority 3: Achievement

Strive for accomplishment and competitiveness of individuals, clubs and regions, within a welcoming, inclusive, fun, and family environment.

#### Priority 4: Partnerships

Strengthen our profile, identity, influence, and relationships with the broader community.

## **Secretary Treasurer's Report**

As of March 31, 2016, BCSSA continues to be financially healthy and has continued to provide opportunities for training and competition in communities of British Columbia. The Board of Directors has continued to ensure prudent financial management practices are in place, providing direct benefits to our member clubs and athletes.

In fiscal year 2016, the Board has continued to focus its efforts to provide financial relief and assistance programs to BCSSA member clubs and regions. During the year BCSSA distributed funds and/or covered expenses in the following categories:

•	Capital funding grants	\$ 26,416
•	Hy-Tek software upgrades	\$ 12,996
•	Officiating supplies distributed	\$ 4,568
•	Financial aid	\$ 3,065

There have been no significant changes to BCSSA's operations or controls. As in prior years, a financial peer review was once again conducted this past June. This review has specific procedures conducted over revenues, expenses and balance sheet line items. I would like to thank Jennifer Ng for volunteering her time to perform this peer review. All recommendations have been taken into consideration and any financial adjustments were made accordingly.

The following is a summary of the fiscal year's financial results:

- Registration income increased by 2.2%. This is directly tied to a slight increase in overall registration in both summer and winter membership categories.
- Interest income decreased as compared to the prior year. This is the result of market driven term deposits maturing in the prior year. No long term investments matured in the current year.
- The 2015 Coaches Conference was held at RockRidge Canyon, in Princeton, BC. This
  event generated approx. \$16,200 in revenue compared to \$NIL in the prior year. Expenses
  in the current year also increased compared to the prior year. Overall, BCSSA budgeted to
  operate both years at a loss, and therefore was able to set participant fees at a lesser rate
  for member clubs.
- The staging of the 2015 Provincial Championships saw a loss of \$(14,259). This was the result of increased facility rental costs and increased board member expenses due to the event being on Vancouver Island. It was originally expected to receive increased sponsorship revenue; however this did not come to fruition. The organization aims to run this high caliber event on a break even basis and the 2016 budget has been adjusted to ensure we are able to meet this target.
- Program operations overall saw an expense increase of 32%. This increase is attributable
  to the coaches' conference, provincials, club reimbursements, and additional scholarships.
  New in this fiscal year, BCSSA provided eight regional scholarship prizes in addition to the
  two Ian Allen Scholarships already provided.



Administrative expenses overall remained consistent year over year. Insurance once again
saw a decrease thanks to the current insurance market rates. Expenses related to running
our Provincial Office decreased slightly in the year as a result of various efficiencies. The
increase in Professional Fees is due to additional legal costs related to various legal
matters which required advice from counsel, including the ongoing negotiation and work
related to online registration and our privacy policy.

During the January 2016 board meeting, BCSSA approved a registration fee increase to \$35.00 per athletes/coach for summer membership, as well as increased annual club affiliation fee to \$100 per year, effective May 1<sup>st</sup>, 2016. This increase is tied to the fact that registration fees have not increased since 2007. This year there were several initiatives started and completed for officials in the BCSSA. The most notable and wide reaching was the "Train the Trainer" program for presentation of Harassment and Conflict Resolution Clinics that took place in April. Many thanks to the financial support of the BCSSA and Regional Boards and to our trainees for sparing a weekend for this. A specific "shout out" to our former president, Neil Wuolle, for training all of us with his vast knowledge, experience and terrific sense of humour. We now have 15 trained conductors to present these two clinics, which are not only necessary for officials, but invaluable for club and regional executive, coaches and swimmers. Previously, the clinics had been offered only at Provincials and periodically otherwise. We have had a minimum one presentation in each of the regions already this summer! As wonderful as the BCSSA is, stressful situations are inevitable, and these clinics provide insight into how to handle conflict, stress and unwelcomed encounters.

The 2016 BCSSA Rulebook was also completed! YAY! It is now in the hands of all the officials and coaches in the province in paper or mobile version. Officials everywhere have been helpful by finding typos (only two!!). It has been thoroughly stressed that there were no changes to the rules but just rewording for clarity. So many people were involved in this production! THANK YOU to all!

I have only had the opportunity to travel to the Kootenays and the Okanagan this year, and I not only felt incredibly welcomed, but was thoroughly impressed by the quality of the officiating, the relationships on deck and the passion everyone shows for summer swimming. I know this is what we have all through our association. I do also stay in regular communication with the Regional Directors of Officials, we have been working closely to help make sure coaches and officials are clear about rules and conduct. One of my favourite initiatives has been providing training for coaches, parents and officials on how to write protests and conduct juries. ## Registrar's Report

I would like give a big thank you to all the Club and Regional registrars! Another year under your belt and I appreciate the amount of volunteer time you commit to making BCSSA such a wonderful opportunity for so many athletes. We honestly could not run our programs without you! Disa (and now Bianca too!) in our BCSSA office are also very important to the organization. The feedback has been excellent on her customer service and her timely information. Disa has been invaluable to me on the registration side, which I so want to thank her for.  $\odot$ 

#### On-line Registration update:

There is a lot to do for our club and regional registrars and the overwhelming sentiment is we need to change our process. Currently it is too time consuming and too easy to make mistakes. Our registrar position is becoming a 'one year, volunteer-and-go' position. There is too much turnover. For the second year in a row we have over 5,900 athletes and we need to find a way to implement on-line registration. Several clubs are blazing the trail for us and I am thankful we will have their experience for the provincial rollout.

I believe the lawyers have ironed out an agreement with Active Networks so I am hopeful we are moving to get this rolled out for winter maintenance this year and then all clubs in 2017! I truly believe on-line registration needs to be a priority.

#### S & O update:

The S and O Declaration form that was implemented in 2015 has been a success. The number of challenges has decreased dramatically and the associated ill will we have seen over this status in the past has been greatly reduced. A suggestion from the Vancouver Island region to make the form even more detailed will be implemented for registration in 2017 and perhaps a discussion with coaches at the conference next May.

#### Water Polo update:

Water polo eligibility/transfer issues have also been almost nonexistent this year and I attribute that to Danny putting together several round table discussions during Provincials last year. So many people took part and it was great to see the water polo community taking ownership of the decisions that were made and brought back to the board. I believe the decrease in the number of water polo issues is due to this awareness.

Perhaps Provincials is a good place to discuss such topics. It is one of the few times each year when many people across all of BCSSA are together. We share a common interest to make BCSSA better so what better place to open up the floor!

In 2014 it was the S&O Rule and in 2015 it was Water Polo, what will be next? See you at the pool!

## **Director of Diving's Report**

In 2016 we had three clubs with diving programs, representing two regions: Coquitlam Sharks (SF) with 24 divers, Burnaby Barracudas (SF) with 15 divers, and North Vancouver Cruisers (V&D) with 50 divers.

Participation at dive meets was excellent with great competition! Diving requirements were reviewed last year and modified to require fewer dives per event. This helped keep the events moving and allowed more children to compete.

We had two new coaches this past summer, one from iDive and one returning BCSSA coach. I will continue to work with BC Diving to provide Dive Coach Training programs and to source qualified coaches for clubs who are interested in starting dive programs as it can be difficult for clubs to find qualified coaches. We brought in Al Hungerschafer from BC Diving to conduct a Judging Clinic for parents/junior coaches and had great attendance. I will be encouraging those who participated to shadow judge at Regionals/Provincials and hopefully some will be willing to act as judges next year. This will help relieve the pressure on coaches, so that they can focus on coaching their divers, rather than judging.

Burnaby Barracudas have not been able to secure regular access to a 3m diving board, however have developed a successful dive program using only a 1m board. Coquitlam Sharks had a strong winter training program which was well attended. North Vancouver Cruisers has had a very successful program this year and will be looking at increasing coached time/practices next year. The number of trophies awarded at Provincials has been reduced from seven to four to reflect the fewer numbers of clubs competing at Provincials. This will be evaluated on an annual basis.

The 2016 Diving Requirements were reviewed and edited after feedback received at the 2015 Coaches meeting. These lists will be reviewed again, with particular attention paid to the requirements for 15+ divers. Also, the 'O Cat' exemption for 13&Under will be reviewed. The BCSSA diving rules need to be reviewed as there are some discrepancies with how meets are actually run/judged. I will ask for assistance from experienced BCSSA coaches and BC Diving to review, update and clarify the rules.

The limited number of clubs with active diving programs affected the opportunity for inter-club meets and the overall competitiveness of both Regionals and Provincials. To support a strong diving program, we need to encourage more clubs and regions to participate. Fraser Valley region has expressed interest in forming a dive program next year. I will assist them however necessary to help that happen. I will also continue discussions with other clubs to encourage them to develop/reinstate dive programs.

Please do not hesitate to contact me if you are interested in investigating opportunities for a dive program for your region/club. Diving programs can be very successful without requiring a significant investment in additional pool time or coaching, and as Burnaby has demonstrated, you don't even need access to a 3m board! I will also assist with finding qualified coaches and providing information on dive coach training opportunities.

## **Director of Synchro's Report**

We now have six synchro clubs in the Lower Mainland: North Delta, Crescent Beach, Haney, Pacific Wave, Coquitlam and North Vancouver. We are also thrilled to have the Dawson Creek Seals bring a group of athletes to compete at Provincials this year. We continue to attract boys to the sport which is very good news for synchro. This year we have added the mixed duet category to our meets and are hoping to see some great duos!

We will have over 100 swimmers at Regionals at the Guildford pool in Surrey this year which is very exciting. We have many beginner synchro swimmers which is promising for the continuation of the sport of synchronized swimming. The Lower Mainland clubs participated in the Hootenanny in Richmond this year; the swimmers competed their figures and were very successful.

We have had a few teleconferences with the directors, judges and coaches this year to discuss the results of last Provincials, how we can improve, as well as preparing for the upcoming 2017 Regional and Provincial meets. Coaches were able to ask questions about the meet package and what is to be expected of their athletes.

Once again this year has proven to be quite challenging in obtaining qualified judges for our meets. One difficulty is the timing of our meets during the week (Regionals) and the coinciding World Championships and BC Summer Games taking a lot of judges for their events. We only have about four BCSSA judges and we really do need to push to have our parents more involved in learning how to judge these events. I will be putting together a letter to be sent to all families encouraging them to take some time to learn to judge and dates for training in the fall.

We continue to partner with Synchro BC and I will be meeting with the Executive Director in August to talk about how we can assist each other to grow the sport.

We thank the BCSSA Board for their continued support to synchronized swimming and look forward to what the future may bring.

## **Director of Water Polo's Report**

It has been a busy spring and summer for BCSSA water polo. In February, the directors, coaches, and regional directors gathered in Burnaby to discuss a number of changes, to both eligibility rules and to develop a new set of rules to encourage fair play in the U12 category.

To that end, a consensus was reached and our set of rule changes was approved by the BCSSA board ahead of the summer season. Feedback so far on the rules has been extremely positive – especially the move to smaller nets in the U12 category. Moving forward, it seems as though small nets will be the standard for U12 play, which would likely necessitate BCSSA purchasing a set of junior size inflatable nets ahead of next season.

A number of teams have developed their own U10 programs, or "splash polo" programs to encourage non-competitive play between extremely beginner-level athletes. The Haney Neptunes even hosted a U10 "tournament" at their annual Canada Day tournament, and feedback was positive from this event. There has been some interest expressed to me through club directors to see this category officially recognized by the BCSSA, and those discussions will continue after the 2016 season's conclusion.

The Neptunes also traveled to the Oregon Open Water tournament in July, and the experience and level of play was very comparable to BCSSA's level. Numerous families have contacted me to urge more participation from BCSSA teams in this event next season.

The changes to eligibility rules have resulted in minimal complaints, although there was an exemption request made by the Coquitlam Sharks, which was ultimately denied. This was the only exemption request which I directly ruled on – a significant decrease in what the board dealt with last year, as I understand it.

While there was no Team BC program this year, and therefore no way to test the second half of our eligibility rules, we look forward to putting these rules into place as the Team BC program returns (expected in 2017).

Lastly, a number of summer clubs who compete in the Lower Mainland Water Polo League in the fall have contacted me directly to inquire about the possibility of using BCSSA insurance, rather than BCWP insurance, to run their league in the fall/winter. I've attached a copy of the email sent to me by Antony Cowie (Director of the LMWPL) to this report. In it, two key questions are posed to the BCSSA board:

- Would the BCSSA support BCSSA clubs continuing their water polo scrimmage and tournament play between September and April?
- And, would it be possible for non-summer clubs to be member clubs in the BCSSA even if they
  do not participate between May and August?

Moving forward, our priority in the off season will be to continue to tweak the U12 rules after this season's experimentation, and to look at the viability (or usefulness) of creating a U10 category. Depending on the board's opinion on the Lower Mainland Water Polo League question, bringing this league into the fold might also be a priority in the fall and winter.



And as a personal note – shortly after the start of May, I moved up to Merritt to accept a job as the editor of the Merritt Herald. While this has unfortunately meant that I am absent from the pool deck at most tournaments, I've made efforts to stay abreast of the goings-on during the tournament season. Should the board consider me unsuitable for this position given my geographic location, I would understand being asked to resign – if this is not the case, I'm happy to serve another year as Director, as I feel we have accomplished a great deal in a short amount of time.

#### LETTER RE: LMWPL JOINING BCSSA

"The LMWPL has asked me to enquire about our league changing its affiliation in the near future. Essentially we would like to continue a format similar to the current weekly league game with sessional tournaments, but under the BCSSA. Six of the nine current LMWPL clubs are BCSSA clubs. They are: Abbotsford Whaler, Haney Neptunes, Langley Water Polo Club, North Delta Sunfish, Surrey Orcas and Vancouver Vipers.

The remaining three clubs, North Vancouver WPC, Burnaby WPC, and Coquitlam Lions, are all in municipalities with a BCSSA club. They have expressed an unwillingness to operate under their summer clubs, as they feel they would lose gaming funds and operational control. The Lions, in particular, have asked if it would be possible for these clubs to be affiliated with the BCSSA for off-season (i.e. not during the summer) play only. This is just a question and won't determine whether we will seek to operate the LMWPL under BCSSA. Could I ask you to present these questions to the board and get back to me.

Namely, would the BCSSA support BCSSA clubs continuing their water polo scrimmage and tournament play between September and April?

And, would it be possible for non-summer clubs to be member clubs in the BCSSA even if they do not participate between May and August?

Thank you very much for your help with this.

This kind of describes our year in Fraser South. On the surface, I would say we had a pretty smooth, almost uneventful season in 2016 but when you look below the surface, you realize how many people are paddling like crazy to make it appear so calm. Special kudos to the Richmond Kigoos – who had to deal with the loss of their home pool due to structural/mechanical issues just before the start of the summer season. Working closely with the city of Richmond, they were able to save the summer program for 200+ swimmers spread out over several pools in Richmond. It must have been a logistical nightmare on such short notice.

Fraser South welcomed two new clubs to the region this summer: Pacific Wave Synchro and Surrey Orcas Water Polo. Both clubs are starting small in BCSSA and will hopefully continue to build their summer programs in the years to come. It should be noted that the addition of these two clubs allowed Fraser South to take back the 'largest region' crown that was lost to Simon Fraser last year! Most of the other clubs in our region are again nearly full to capacity. Pool space limits our capacity more than anything in Fraser South, even with two new pools opening in Surrey. Speaking of which, WRASA will be hosting the first ever BCSSA meet in the new Grandview Heights Aquatic Centre July 23/24. We're hoping everything will be "calm on the surface" but an unbelievable amount of 'paddling beneath the surface" has gone into planning and executing one of the first big public meets ever in this new pool. We're hoping this pool is a potential site for Provincials in the future, but it won't be ready for that until there is more development – specifically parking spaces – around the pool. Kudos to the WRASA Meet organizers!

If more pool space were to open up in the region, we could get more kids, but that would also mean we need more coaches. Coaching development remains a high priority for our clubs as it is one of the keys to continued success. Fraser South sponsored a coach from each club to attend the Coaches Conference in Princeton, and many of the clubs sent several coaches. The event was very well received and I know coaches are looking forward to returning to Rockridge. Special thanks to Lindsay and Disa from BCSSA for all the 'paddling beneath the surface' for the Coaches Conference.

As our clubs grow – several are now well over 150 – we're starting to experience 'growing pains' where we're starting to test the boundaries of 'reasonable' volunteer time. Many of our Club Presidents, Registrars, and other executives spend many hours, well into the night, working out issues and keeping the clubs running. It can be hard work on top of already busy lives and takes some very special people to do it. It also has at least one club seriously looking into the viability of hiring a club manager, much like what Disa does for the BCSSA. A huge thank-you to all the club executives and volunteers that make this all work.

And finally – Good Luck to all our athletes and coaches who have all been working so hard leading up to regionals and provincials. If anyone epitomizes 'paddling hard beneath the surface' it's them!

Our Region appreciated equipment partnerships with other regions as we both accepted used equipment and gave used equipment. Thank you to those regions! Thank you also to the BCSSA for its capital grant program which enabled us to purchase new headsets for our radios. Thank you also to Chris and Cheri Ruim who ran a Registrar Clinic in early June.

We lost the Victoria Hammerheads this year, but many other clubs saw growth. Overall, our registration numbers increased for the fourth consecutive year and attendance at swim meets was consistent throughout the Region. Some of our swimmers attended out of region meets and enjoyed being hosted by other clubs and swimming against swimmers from other regions - usually something limited to Provincials. More importantly, some swim clubs from other Regions attended meets on Vancouver Island. Particular thanks go to swimmers from the Chilliwack Stingrays, Langley Flippers, North Shore Winter Club, Port Coquitlam Marlins, Richmond Kigoos and Vancouver Vikings who made treks to our Region. We hope to see you again and that you bring some friends! Our 2017 and 2018 meet schedules are posted on the BCSSA calendar.

The success of the Region this past year again was based on the parent volunteers. From those parents who sat as timers, to those parents who deliver deck food, to those parents who have trained as officials, to those parents who keep the console running, the dedication and support for their childrens' activity keeps the Region strong. In particular, our Regional Director of Officials, Mike Craig, continued in his second year in the position to recruit and train new deck officials, who are a huge part of our Region's future. As we move forward into the next season, I will be asking the Clubs to focus on recruitment and retention – problems that exist in all sports and volunteer organizations. I would like to especially thank those who volunteered to be on the Regional and Club Boards. The extra hours that you have put in, and continue to put in, are truly appreciated.
